Program Eligibility and Agreement Form
Hartford Recreation Center Membership / Corporate Fee Plan & Agreement Terms

The Corporate Membership Program is open to any business or service club, "Corporation". Not only will the Corporate Membership give your employees a discount on Recreation Center memberships; it encourages them to participate in programs and services that result in a healthy lifestyle.

Corporation Participation Level

The Corporation agrees to enroll in the Corporate Membership Program by completing the Annual Corporate Enrollment Form and paying the appropriate enrollment fee.

The enrollment fee is based upon number of employees, which includes all full time and part time employees working at the time of the Corporation's enrollment. Spouses and children of the employee are only eligible within the family membership.

The Corporate employee will bring in a recent pay stub, letter from the Corporation's human resource department or other type of proof of employment at the time of enrolling for a membership to verify employment.

The Corporate employee enrolling for a membership will complete and sign all membership enrollment forms. The employer can provide this form or the employee can pick the forms up at the Recreation Center.

The Corporate employee enrolling for the membership must have full payment (less the 10% discount) at the time of enrollment.

The Corporation and/or employees who leave the corporation will not be reimbursed any membership fees.

For each annual enrollment, the corporation will receive \$5. This will be applied to the next year's enrollment fee or refunded at the end of the Corporate Membership year. The Corporation can recover all but \$30 of the enrollment fee through a credit program.

All rules and regulations for Recreation Center memberships apply to individuals in the Corporate Membership Program.

Enrollment fee is non-refundable.

Discount / Benefits to Corporate Members

Employees of the corporation will receive 10% discount off any membership during the year the Corporation's membership is active.

The 10% discount does not apply to the processing fee that is paid on new memberships.

Discounts will not be issued on previously paid memberships.

This discount can not be used with any other promotions/discounts.

Corporations are eligible for the following benefits once five annual enrollments have been received and until the end of their current annual Corporate Membership:

15% discount on private pool rental at the Signicast Family Aquatic Center

10% discount on room rentals at the Recreation Center

One free personal training session for every 5 annual enrollments.

\$10 off Adult Volleyball and Adult Basketball leagues sponsorships
